AIMS & OBJECTIVES

- Analyse the legal framework and identify challenges in police-community relations, including trust deficits and communication barriers.
- Evaluate the effectiveness of community policing initiatives and the role of technology in fostering collaboration.
- Recommend reforms and engagement strategies to enhance trust and fairness in policing practices.

KEY FINDINGS

- 54% believe police do not treat all community members fairly
- Mixed satisfaction with police responsiveness, with 32% participants expressing dissatisfaction.
- Low trust in local police, with 13% rating it as very low or low

RESEARCH METHODS

- Survey: An anonymous online survey gauged Derby residents' perceptions of law enforcement.
- Policing Initiatives: Analysd the effectiveness and legal compliance of community-oriented policing initiatives, including youth outreach programs.

ANALYSIS

Survey responses from Derby residents reveal a significant lack of trust in local law enforcement, with many expressing or neutral confidence. Effective communication and timely responses are essential for building trust. Additionally, over half of participants believe the do not treat all community police members fairly, indicating perceptions of inequity. These findings highlight the need for targeted reforms to enhance accountability, transparency, and collaboration between police and the communities they serve.

CONCLUSION

This research highlights significant mistrust between law enforcement and communities, particularly in Derby. Findings indicate a need for improved communication and fairness in policing. To rebuild trust, law enforcement must prioritise effective engagement and community-oriented initiatives. Targeted reforms are essential for fostering a more collaborative and equitable policing environment.
